

## NPU Terminology Terms of Use

### License & Terms of Use:

Permission is hereby granted in perpetuity, without payment of license fees or royalties, to use and copy the NPU Terminology content in all formats in which it is distributed by Statens Serum Institut, or supplied by a licensed NPU National Release Center for any commercial or non-commercial purpose, subject to the following terms and conditions:

1. To prevent the dilution of the purpose of the NPU Terminology of providing a definitive standard for identifying clinical patient observations, such as laboratory test results, users shall not use the NPU Terminology, its name and OID 1.2.208.176 and the code system identifier 'NPU' for the purpose of developing or promulgating a different standard, coding system or terminology.
2. The publications of NPU terminology content consist of three main sets of data: NPU definitions and codes, terms and terminological references, and NPU group structures (lists). Users may download access or receive the publications of NPU Terminology content in English, as available from [www.labterm.dk](http://www.labterm.dk), [www.npu-terminology.org](http://www.npu-terminology.org) or [www.ifcc.org](http://www.ifcc.org), or as original or translated versions published by a licensed NPU National Release Center. Users may use these publications and may modify them as permitted herein. Users may not use or modify NPU Terminology content publications for purposes unrelated to identification of clinical patient observations, unless prior written permission is granted by the NPU Steering Committee.

3. Users shall not change the meaning of any of the NPU codes, definitions or terms. Users shall not change the content of any part of the NPU Terminology publications.
